

RSES company competence list

The list indicates companies that employ security engineers or specialists whose competence has been assessed either by:

- Peer-review for admittance to the register
- Application to add additional primary categories. This is by peer-reviewed assessment of a registrant's application that considers their experiential learning, Continuing Professional Development (CPD) and underpinning knowledge
- The verification of competence for each secondary category. This is determined by self-assessment and peer-reviewed assessment where a registrant's capability is demonstrated by experiential learning, CPD and evidence of industry practice, i.e. working on active projects and advising on the respective specialism

Both additional primary and secondary categories are listed for Principal or Member Grade only. Details of each category and grade can be found in the [RSES Guidance](#).

The table is based on data from members with details of their current employment and is correct at the time of publication. It is recommended that those wishing to engage companies to supply security consultancy services ask for confirmation of their employees' categories beforehand as the member's current employment may have changed.
